- 4. The WVU Fire Service Extension Office will review your application. If you are eligible, your application will be certified, approved and forwarded onto the DMV. These plates are available ONLY by mail. Due to the limited number of plates, these plates are not available at DMV Regional Offices. - 5. All checks should be made payable to the Division of Motor Vehicles. Please include your personal property tax receipt or affidavit from the assessor; if your registration is expiring within 60 days of your application.

Your fee is based on the expiration of your present license plate. Use the first letter or number of your license plates to calculate your fee. This amount includes the one time \$10.00 fee. All Certified Firefighter license plates will expire July 1 of each year. Your renewal fee will be \$30.00 per year.
