WVU AgTech Mini-Grant Program

WVU Extension and WVU Davis College are excited to offer a third round of AgTech Mini-Grants to West Virginia 4-H and FFA clubs, groups and individuals. Provided by a generous donation from Karen Powell, up to five \$2,000 mini-grants will be awarded to support technology related to agriculture in either the farm or classroom setting.

Technology has always driven innovation in agriculture to help increase productivity, yields, safety, operations and management. With this mini-grant program, your project should aim to apply technology to a need on your farm or in your classroom that will improve your operations, help spur innovation, increase productivity, or even lead to a new opportunity for potential business. This grant will allow you to be creative and identify a modernization, upgrade, new technology or innovation that can make your farm or classroom more successful. Grant applications are now being accepted, and awards will be made according to the following guidelines.

Grant specifics:

Project proposals should address a demonstrated technological need related to agriculture. This need can be in a classroom /educational setting or in a farm/field setting. For the purposes of this grant, "technology" could include (but is not limited to) projects related to data loggers, laptops, weather stations, drones, precision agriculture, data management, field mapping, etc. The grant will not be awarded for "equipment" such as tires, machinery, and farm supplies. Awardees will be expected to submit on-time mid-year and final project reports. Specific guidelines for these reports will be provided to awardees.

Timeline:

- December 10, 2025 Application deadline
- December 17, 2025- Award recipients will be notified
- December 17, 2025 January 16, 2026- Mini-grants will be disbursed
- April 15, 2026 Mid-project reports due
- August 5, 2026 Final reports due
- TBD Final Banquet and Project Presentations

Applicant criteria:

Teams/clubs may apply for this grant, but a 'lead' applicant, meeting the criteria, must be listed.

- 1. Adult guidance is encouraged, but this grant should be written by a youth member or team.
- 2. Applicant must be an active 4-H or FFA club member.
- 3. Applicant must be at least 14 years old as of 1/1/2025. Applicant must be no more than 21 years old as of 1/1/2025.
- 4. Application must have signed approval of the county Extension agent.
- 5. Previous recipients of the AgTech grant are ineligible for a second grant.
